#### Terms & Conditions for Flowerpots Properties

Welcome to Flowerpots Properties. By booking and staying at our properties, including but not limited to Nettle Cottage, you agree to the following Terms & Conditions. These terms are designed to protect both you (the guest) and us (the host) to ensure a pleasant and secure stay.

# 1. Booking & Payment

- 1.1. Full payment must be made at the time of booking unless otherwise agreed.
- 1.2. Bookings are only confirmed upon receipt of payment and acceptance of these terms.
- 1.3. The primary guest must be at least 18 years old and provide valid identification upon request.
- 1.4. The maximum number of guests allowed in the property must not exceed the agreed limit.

## 2. Security Deposit & Damages

- 2.1. A refundable security deposit may be required at the time of booking. This will be refunded within 5 days after check-out, provided there are no damages, missing items, or breaches of these terms.
- 2.2. Guests are responsible for any damage, breakages, or loss caused during their stay, whether accidental or intentional.
- 2.3. If damage or missing items exceed the security deposit, we reserve the right to charge the guest for the full cost of repair or replacement.
- 2.4. Any issues must be reported immediately. Failure to report damage may result in additional charges.

#### 3. Check-In & Check-Out

3.1. Check-in time is from 15:00pm and check-out time is by 10:00 am. Early check-ins or late check-outs must be pre-arranged and may incur additional

fees.

3.2. Failure to check out on time without prior agreement may result in an additional night's charge.

#### 4. House Rules & Conduct

- 4.1. No Smoking Policy We are a strictly no-smoking property. Smoking or vaping is not permitted inside the house or near open doors/windows. A cleaning fee will be charged for any violation of this rule.
- 4.2. No pets allowed unless pre-approved in writing.
- 4.3. No parties, loud music, or disruptive behaviour that may disturb neighbours.
- 4.4. Guests must keep the property clean and tidy. Excessive mess may result in additional cleaning fees.
- 4.5. Any illegal activity is strictly prohibited and will result in immediate eviction without refund.

#### 5. Log Burner & Fire Safety

- 5.1. Guests using the log burner do so at their own risk. While we provide clear instructions and a fire guard, we are not liable for any injuries, burns, or accidents resulting from its use.
- 5.2. The fire guard must always be used when the log burner is lit.
- 5.3. Children and pets must never be left unattended near the log burner. It is the guest's responsibility to ensure their safety.
- 5.4. Do not use excessive firewood or flammable liquids in the log burner. Misuse may result in eviction without refund.
- 5.5. If the log burner is left burning unattended and causes any damage, guests will be fully responsible for repair costs.

#### 6. Injuries & Liability

- 6.1. Guests stay at the property at their own risk. We are not liable for:
  - Accidents, injuries, or illnesses that occur during the stay.

- Slips, trips, or falls inside or outside the property.
- Injuries caused by improper use of the log burner or any other household items.
- 6.2. Guests are responsible for ensuring their own safety and that of their party, especially when using stairs, outdoor areas, or the log burner.
- 6.3. We are not liable for loss, damage, or theft of personal belongings.

# 7. Lost or Missing Items

- 7.1. Guests are responsible for their personal belongings. We are not liable for any lost, stolen, or forgotten items.
- 7.2. Any items left behind will be kept for 14 days and can be returned at the guest's expense.
- 7.3. Missing or stolen property belonging to Flowerpots Properties will be deducted from the security deposit, and additional charges may apply if necessary.

#### 8. Cancellations & Refunds

- 8.1. Cancellations made 30 days before check-in are eligible for a full/partial refund (subject to our cancellation policy).
- 8.2. No refunds will be issued for cancellations made within 30 days of checkin unless due to exceptional circumstances.
- 8.3. If the property becomes unavailable due to unforeseen circumstances (e.g., maintenance issues, natural disasters), we will offer alternative accommodation or a full refund.

## 9. Breach of Terms

- 9.1. Violation of these terms may result in immediate eviction without a refund, forfeiture of the security deposit, and legal action if necessary.
- 9.2. We reserve the right to charge additional fees for any breach, including but not limited to:
  - Unauthorised guests staying at the property.
  - Excessive cleaning required after departure.

- Damage to property or missing items.
- Noise complaints or neighbour disturbances.
- 10. Privacy & Data Protection
- 10.1. Guest information will be handled in accordance with GDPR and UK privacy laws.
- 10.2. We will never share personal information with third parties except where legally required.
- 11. Amendments to Terms
- 11.1. Flowerpots Properties reserves the right to amend these terms at any time. The most up-to-date version will always be available before booking.
